# **Privacy Policy transparently**

ARCHE is strongly committed to the protection of your personal data.

This Privacy Policy transparently outlines the manner in which ARCHE collects, stores, uses and shares your personal data when you visit the website <u>http://www.ARCHELEGAL.net/</u> (the 'Website') and/or when you request services or information offered on the Website (the 'Services').

When appropriate, this Privacy Policy is supplemented by our General Terms and Conditions of Service, which are attached to ARCHE's engagement letters, and by the required legal information provided on our data collection forms.

By using the Website, you accept this Privacy Policy.

## Personal data that you communicate

You are not required to provide any personal data when you visit this Website.

ARCHE only collects data which is strictly necessary to provide the Services.

If you wish to benefit from the Services offered by ARCHE on the Website, you need to follow a quick registration process which involves giving your surname, first name and email address.

If you wish to use the online recruitment process, you are required to communicate your surname and first name, your profile (lawyer, trainee, administrative position), your email address, as well as a resume and a covering letter in an adapted format.

If you fail to transmit such information, ARCHE will not be able to provide you with the Services you have requested.

When you use the Contact Form to transmit your enquiries, you should avoid disclosing confidential information. In fact, if you are not a client of ARCHE, you risk that this information may not be covered by professional confidentiality and may be disclosed to third parties.

## **Purposes of collecting data**

The personal data collected on the Website are processed mainly for the following purposes :

- management of newsletter subscriptions and other communications of the law firm ;

- management of job applications (lawyers, trainees, administrative position);
- processing of your requests via the Website ;
- improvement of the content and navigability of the Website.

## Sharing and transfer of data

Transfers of data shall be made within the framework of standard contractual clauses validated by the European Commission in accordance with the regulation in force. The Website is hosted on servers located in France.

ARCHE saves the personal data on secure servers located in France.

## Cookies

## General provisions on cookies and the automated collection of your personal data

When you access and use the Website, ARCHE may capture information - in accordance with the applicable laws and with your consent if so required - about your end devices or networks, in particular : your IP address, connection data, type and version of the internet browser used, type and version of the plug-ins of your internet browser, operating system and platforms, data regarding your browsing history on the Website, specifically your browsing history on other webpages of the Website, the content you have used, the search terms used, the duration of your stay on certain webpages, interactions with the webpage and any telephone number used to contact ARCHE.

Among the technologies used to collect the data, ARCHE mainly uses cookies, which are small files comprising text and digits downloaded from your end device when you access the Website.

#### **Cookies used**

These cookies can be of different nature :

• Function cookies and cookies required for the functioning of the Website : they are necessary for the proper operation of the Website and to access the functions aimed at ensuring your convenience while navigating. ARCHE uses Google Analytics, a statistical analysis tool for internet websites.

#### **Management of cookies**

#### **Storage duration**
